# ■ Master in Human Rights and Rule of Law



**Apply for** our Human Rights and Rule of Law postgraduate specialist programme in the academic year 2024/2025 and get a competitive qualification at the Faculty of Law, University of Miskolc.

■ **Dealing with human rights issues is a task that requires specialised knowledge and responsible thinking.**

The aim of the programme is to provide participants with a comprehensive theoretical and practical knowledge of human rights and the rule of law, with special regard to the specificities of Central and Eastern Europe. The course will provide students with an introduction to the main philosophical, dogmatic and institutional features of universal and regional human rights protection, followed by a detailed study of the framework provided by the UN and the European Convention on Human Rights, as well as the legal possibilities of the European Union in this field. The course also aims at presenting Central and Eastern European human rights issues, interpretations and good practices, as well as at systematising and analysing international case law from a comparative law perspective, and, on this basis, at outlining the main trends. The course will also cover the development of the supranationalisation of the concept of the rule of law and constitutional identity, and not least the frontier areas of human rights (international environmental protection, protection of vulnerable groups, international criminal law, international humanitarian law, international refugee law).
